- 1.) One check shall be a joint check payable to Glendale Plumbing & Fire Supply, Inc and subcontractor for the amount specified in Glendale Plumbing & Fire Supply's preliminary lien notice release.
- 2.) The second check should be a single party check payable to the subcontractor for work performed before the date of Glendale Plumbing & Fire Supply's preliminary lien notice release.

The parties understand and agree that the subcontractor is an independent contractor and is not the agent, partner of joint venture of General Contractor of Glendale Plumbing & Fire Supply. In the even of any dispute relating to this agreement, the successful party shall be entitle to reasonable attorney's fees. The subcontractor hereby appoints Glendale Plumbing & Fire Supply, Inc as its *Attorney in Fact* to sign its endorsement to the back of any jointly payable checks received from the General Contractor.

This agreement shall be binding upon and insure to the benefits of the parties hereto and their respective heirs, executors, administrators, legal representatives, successors, and their respective heirs, executors, administrators, legal representatives, successors, and assigns where permitted by this agreement.
